Ellingham Community Trust

Minutes: 13th May 2021, 7pm

1. Approval of Minutes:

Draft minutes of 8th April 2021 were approved, proposed by Judy Glover and seconded by Robert Stuart.

3. Treasurer's Report

a. Treasurer's Reports

Louis Fell delivered the Treasurer's report.

Total in the bank is £59,662. Louis Fell noted that there has been very little activity, specifically three Domestic Appliance Scheme applications (£300), since the last meeting. The Trustees noted that this is a quiet time of year for applications. The Treasurer noted that the Windfarm money will come in after the interest rate is set. Louis Fell noted the potential increase in logs for the solid fuel scheme.

4. Applications

a. Update: Ellingham Village Hall & St Maurice's Church.

David Milne noted information received from Ellingham Village Hall regarding an increase in costs for the full build, and a possible need for additional funding or phasing of the project. Louis Fell noted an increase in the costs of steel and timber owing to the Covid-19 pandemic. The Trustees discussed the issue of the increase in costs. David Milne noted that there had been no response from Northumberland County Council regarding a loan.

No further update from St Maurice's Church. The Trustees noted St Maurice's Church were not in a position to do anything until November 2021 owing to the Covid-19 Pandemic.

a. Domestic Appliance Scheme (DAS)

George Unwin noted that three applications were received since the last meeting. The scheme continues to be popular.

b. Solid Fuel Scheme

The Trustees re-iterated the desire to review all the schemes at the next physical meeting.

c. Personal Development Scheme.

George Unwin updated the Trustees with the current status of the repair of the Interactive Lights. Mr Unwin noted that one light has been fixed, but the other still needs attention. Mr Unwin was awaiting good weather to assess the issue.
