1. Approval of Minutes:

3. Treasurer's Report

a. Treasurer's Report

Louis Fell detailed the Treasurers Report

Treasury Account at £34,479.41; Current Account £10,298.58; giving a total of £44,777.99. Payments out included £200.00 for two Domestic Appliance Scheme applications, and £808.00 Accountant's bill. The was no income for this period.

b. School RHI

Louis Fell provided the Trust with further details from the school about the outstanding RHI payments. The school have made a renewed calculation which requires verifying.

ACTION: Louis Fell to check the school calculations and will circulated.

The school have been re-assessed for their Eco 'green school' award and continuously been awarded top 'Gold award' for about ten years for their 'Woodland Workshop' forest school. The school have invited the Trustees to a celebration event.

4. Applications

a. Broadband - Update on Application

Heather gave an update on Broadband. Heather read a note from iNorthumberland detailing a scheme being offered to community members for wireless broadband. Heather noted that this was being listed as an interim solution. The Trustees expressed concerns that this may mean that the main broadband project will be delayed. The Trustees noted that without a signed agreement they could not influence the outcome. Louis Fell suggested that the Trust should get an update on the project. David Milne expressed a need to have a Trust representative on the project team.

ACTION: Louis and Heather to chase the formal agreement.

b. School - Update on Application

Louis Fell The school have not yet received the specification required for the road to take school buses from the Local Authority. Owing to the delay the school has lost match funding from the Diocese. The

Trustees discussed a way forward and identified that accurate costs were needed before any further decisions could be made.

ACTION: Heather Cairns to arrange for the school to host a site meeting with the Local Authority onsite to identify the specification required.

ACTION: Louis Fell to get three quotes for the road once the specification has been received.

c. Defibrillator - Update on Application

George Unwin confirmed that there had been no update owing to the lambing season.

ACTION: George Unwin to progress the application.
