Minutes: 11th April 2019 Ellingham Village Hall

The Trustees welcomed James Mayers as a Trustee. Louis Fell informed James Mayers that he needing details for Companies House and the Charities Commission.

1. Approval of Minutes:

Draft minutes of 14th March were approved. Proposed by Robert Stuart and seconded by George Unwin.

- 3. Treasurer's Report
 - a. Treasurer's Reports

Louis Fell presented the Treasurers Report to the Trustees covering two months.

Treasury Account at £37,158.91; Current Account £16,744.96; giving a total of £53,903.87. Payments out included £300.00 for three Domestic Appliance Scheme applications, £400 for two outstanding Solid Fuel Scheme cash payments, £18.00 for bank charges and £950.40 for the outstanding charge for delivery of heat logs. Income for the period was £36.61 interest. The next Windfarm payment is due in May.

Louis confirmed that he will be authorising David as counter signatory for Unity Bank.

4. Applications

a. Broadband Update

Heather Cairns reported that she had not heard from Heather Smith in regard to the Trust's decision to no longer support Broadband. The Trust agreed that there was no further need for updates.

b. School Update

Louis Fell expressed concern that the RHI funds retained by the school should be ringfenced. Heather Cairns agreed to confirm this. The Trustees agreed that there was no need for further updates.

ACTION: Heather to confirm with the school that they will ringfence the RHI money.

c. St Maurice's Church Repair of the Tower

Trustees had received information from St Maurice's Church informing the Trust that they would only claim £5,658 for the work owing to income from other Trusts instead of £6,550 unless costs change.

d. Village Hall & Church Application Update

Louis Fell has sent a letter to the Wind Farm Company but has not received a response.

5. Update on Active Schemes

a. Domestic Appliance Scheme (DAS)

Three in the last period.

b. Solid Fuel Scheme

Some applications still appear to be outstanding. The Trustees went through the list and checked records. Mr Wallace is no longer living the parish, his payment has bounced but he has not come back to the Trust. Louis Fell delivered a pallet to Preston Farm which was previously outstanding. Craig Miller's application was confirmed as paid £200 on 5th December 2018 by BACS, Tracy Sprigg's application was confirmed as paid on 21st Feb 2019 by BACS, and the hardwood for Harriet Adams' application was acquired, Louis Fell to identify if the delivery was missed.

ACTION: Clerk to email all outstanding enquirers.

ACTION: Louis to chase missing hardwood for Harriet Adams.

The Trustees noted that the administration of the scheme was particularly difficult this year. It was reiterated that George Unwin would manage receipt of the forms for the 2019 scheme. It was agreed that forms would be hand delivered and an acknowledgement email would be sent out to everyone who submitted and application. The 2019 scheme would include wording that if an acknowledgment wasn't received, applicant should get in touch with the Trust.

ACTION: Clerk to create an acknowledgment form.

c. Personal Development Grant application
