1. Approval of Minutes:

3. Treasurer's Report

a. Treasurer's Reports

Louis Fell presented the Treasurers Report to the Trustees.

Total accounts at £53,507. Payments out were £18.00 for Bank Charges. Income received for the period is, £43,987.57 from the Windfarm and £37.06 Bank Interest. Payments pending include funds for the Church Application, Solid Fuel Scheme and School Application.

Louis Fell reported that there was no further update has been received from the Windfarm Company in relation to the discussion of funding for the Village Hall and Church Application.

b. Banking Mandate

Banking mandate completed and David Milne is now an authoriser of payments on the bank account.

4. Applications

a. New Application from Village Hall

The Trustees discussed the application. It was noted that this amount of money requested was within the grant requested within the Village Hall & Church Application. It was also noted that any planning application will last three years. The Trustees had a round table discussion including a dynamic risk assessment of the potential failure of the windfarm to provide with the funds. After the discussion, it was not deemed appropriate to advance this money at this stage. As soon as there is clarity from the windfarm, and the Parish has been re-consulted with information the terms of the arrangement with the Windfarm, the Trustees will reconsider the application.
