1. Approval of Minutes:

Discission of use of laptop by the community. The Clerk noted that she was using another organisation's laptop.

3. Economic Situation.

Judy Glover noted the suggested wording regarding a paragraph for the Parish Magazine.

Ellingham Community Trust are concerned that the ongoing situation in the whole UK could result in some people having difficulty heating their homes adequately this winter. The Trust wishes to offer targeted financial support in order to alleviate this problem to households that include at least one resident over 80 years old.

a. Treasurer's Report. Louis Fell provided the Trustees with the Treasurer's report

Expenditure for the period includes £315.08 for Insurance, and £3,370.50 for the Hardwood Logs. There was no income for the period.

b. Financial Legacy for the Trust

No update. The Trustees requested that this item was left on the agenda.

5. Applications

No new updates on the existing applications.

6. Update on Active Schemes

a. Solid Fuel Scheme

Louis Fell noted agreement on the coal voucher increase to the level of the Hard Wood/Heat Logs and that cash payments would be made shortly. Heat logs are an issue, with concerns that the supplier may not be able to deliver or provide the additional orders. Louis Fell noted the aim to get all of the heat logs delivered

at once with an aim to deliver by mid Dec. The total required are 83 pallets, 30 pallets have been promised by mid-Nov.

The Trustees discussed changing the Heat Log order to Hardwood, but Louis noted that he was currently unable to get these at the same price.

The Clerk noted that parishioners had been enquiring regarding delivery timescales. Louis Fell noted that the deliveries will occur when the Heat Logs were ready.

Trustees noted that a group of parishioners had reported not receiving hard copy forms. The Trustees agreed to pick this up as part of a wash up meeting once the scheme had been put to bed. Louis Fell noted that he had been able to add late applicants on this year. The Trustee discussed and agreed posting hard copy forms in future noting that people open stamped post.

Louis Fell requested that all forms were sent to him for the 2023 scheme.

b. The Green Scheme

George Unwin noted that no application has been received since the last meeting.

c. TESS.

The Clerk reported that no applications have been received since the last meeting.

The Clerk reminded Trustees that she was unavailable for the December meeting. The Trustees were reminded of the agreement to continue the meeting without the Clerk, but with notes taken by one of the Trustees. Louis Fell offered to provide notes for the meeting.
