## 2026 SOLID FUEL SCHEME



### APPLICATIONS NEED TO BE COMPLETED NOW TO ENSURE DELIVERY FOR WINTER 2026.

If your primary residence is within the Parish of Ellingham and recorded on the electoral roll you can apply to the Ellingham Community Trust for a **voucher for solid fuel or equivalent cash by ticking the appropriate box below.**

**If you do not have an open fire or log burner**, it is still worth taking advantage of this offer. It is acceptable to sell the fuel or to pass on as to a gift. Alternatively, you can receive a cash sum from the Trust.

**Second home and holiday let owners are not eligible.** Status of applicants will be checked.

To apply, simply complete the details below by the deadline of **31<sup>st</sup> May 2026** and email a copy to [ellinghamcommunitytrust@gmail.com](mailto:ellinghamcommunitytrust@gmail.com) or post to Virginia Mayes-Wright, 1 Chathill Farm Cottages, Chathill, NE67 5DE. Households submitting after this deadline will only be eligible for the £100 cash payment option.

- A pallet of renewable heat logs from Bedmax (1 tonne).** These will be delivered wrapped on a pallet to your door and come in 20kg sealed bags.
- 2 m<sup>3</sup> of barn dried hardwood logs.** These may be delivered loose by to your door. Help with storage can be provided if needed, please note on form.
- A £250 voucher for coal** from Williamsons of Berwick.
- A cash payment of £250 for households with no ability to burn any of the solid fuel options.** Your bank details must be written on this form. Payment by BACS only.
- A cash payment of £100 for households with the ability to burn solid fuel, but not wanting to apply for it.** Your bank details must be written on this form. Payment by BACS only.
